Replacement of temperature control air compressor

In 2010, RFPL commissioned the engineering firm Engberg Anderson to track our capital assets and assign a schedule for replacing capital equipment as it nears the end of its useful life. The life expectancy of a temperature control air compressor is 20 years. The air compressor was original to the 1992 building addition.

I recommend approval of the attached quote in the amount of \$8,814 from Oak Brook Mechanical to be paid from the Capital Improvement fund.
